We have communicated to you recently that we will be launching an additional layer of security for BrokerHub, known as OTP; a unique six-digit security code that you will enter each time you log in to BrokerHub.

You can now nominate an email address in BrokerHub, where your OTP will be sent. From **Friday 15 November** evening, these OTPs will be used to authenticate your login to BrokerHub. The nominated email address may be a group email address to support admin, team members, and office staff. Log in to BrokerHub via the [broker website](#) to nominate an email address for OTP.
